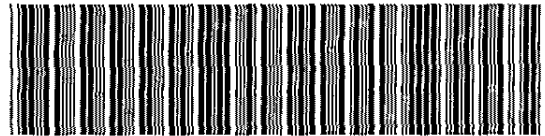

**ARTICLES OF ORGANIZATION OF**

**MAGDALINA DRIVE, LLC**

**ARTICLE I**

**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be MAGDALINA DRIVE, LLC, and the mailing address and street address of its principal office shall be 1426 W. 4th Street, Brooklyn, New York 11024, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

These Articles may be amended by a vote of a majority in interest of the members.

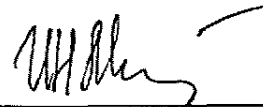
## **ARTICLE VII**

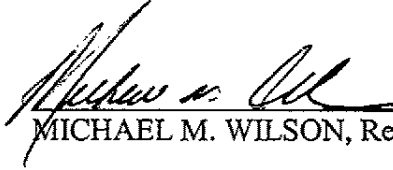
