- SECOND:** The Articles of Organization of JJNM Associates, LLC, were filed on August 31, 2004.
- THIRD:** Article II of the Articles of Organization is amended in its entirety to read in full as follows:

“ARTICLE II

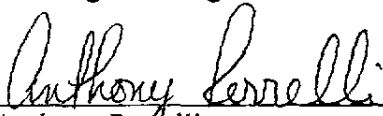
