ARTICLES OF ORGANIZATION OF
INTERNATIONAL CONSULTING OF MIAMI, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be, *International Consulting of Miami, LLC*, and the mailing address and the street address of the principal office of the limited liability company shall 2655 Le Jeune Road Suite 326, Coral Gables, FL 33134

SECOND: *International Consulting of Miami, LLC*, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, *International Consulting of Miami, LLC* is formed are:

- (A) to invest in real estate in the state of Florida; and
- (B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.

FOURTH: The maximum number of ownership units which, *International Consulting of Miami, LLC*, is authorized to have outstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator.


FIFTH: The limited liability company shall be manager-managed and will have one (1) Member:


Designation and Acceptance of Registered Agent
