

## PLAN OF MERGER

PLAN OF MERGER approved on November 5, 2010 by DR. THOMAS BUTERA, DVM, LLC ("DTB-DVM"), a Florida limited liability company, by resolution adopted by its Members on said date, and by PET PARTNERS OF CYPRESS CREEK, LLC ("Pet Partners"), a Florida limited liability company, by resolution adopted by its Members on said date.

- 1. Upon the terms and conditions hereinafter set forth and pursuant to the provisions of the Florida Limited Liability Company Act, DTB-DVM shall be merged with and into Pet Partners, with Pet Partners being the surviving limited liability company upon the effective date of the merger (sometimes hereinafter referred to as the "surviving company"), and which shall continue to exist as the surviving company under its present name pursuant to the provisions of the laws of the State of Florida. The separate existence of DTB-DVM shall cease at the effective time and date of the merger set forth below in accordance with the provisions of the Florida Limited Liability Company Act.
- 2. The Articles of Organization of Pet Partners at the effective date of the merger shall be the Articles of Organization of the surviving company; and said Articles of Organization shall continue in full force and effect until amended and changed in the manner prescribed by the provisions of the Florida Limited Liability Company Act.
- 3. The Operating Agreement of Pet Partners at the effective time and date of the merger will be the Operating Agreement of the surviving company and will continue in full force and effect until changed, altered, or amended as therein provided and in the manner prescribed by the provisions of the Florida Limited Liability Company Act.
- 4. The Members and officers in office of Pet Partners at the effective time and date of the merger shall be the members and the officers of the surviving company, all of whom shall hold their offices until the election and qualification of their respective successors or until their tenure is otherwise terminated in accordance with the Operating Agreement of the surviving company.
- 5. Each membership interest of DTB-DVM immediately prior to the effective time and date of the merger shall, at the effective time and date of the merger, be cancelled and extinguished. The membership interests of Pet Partners shall not be converted or exchanged in any manner, but each said interest which is issued at the effective date of the merger shall continue to represent one membership interest of the surviving company.
- 6. The Plan of Merger herein made and approved shall be submitted to the Members of DTB-DVM and Pet Partners for their approval or rejection in the manner prescribed by the provisions of the Florida Limited Liability Company Act, and the merger of DTB-DVM with and into Pet Partners shall be authorized in the manner prescribed by the laws of the State of Florida.

In the event that the Plan of Merger shall have been approved by the Members entitled to vote of DTB-DVM and Pet Partners in the manner prescribed by the provisions of the Florida Limited Liability Company Act, and in the event that the merger of DTB-DVM with and into Pet Partners shall have been duly authorized in compliance with the laws of the State of Florida, DTB-DVM and Pet Partners hereby stipulate that they will cause to be executed and filed and/or recorded any document or documents prescribed by the laws of the State of Florida and that they will cause to be performed all necessary acts therein and elsewhere to effectuate the merger.
- 8. The Members and the proper officers of DTB-DVM and the Members and the proper officers of Pet Partners, respectively, are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
- 9. The effective date of the merger herein agreed upon shall be the date upon which the Certificate of Merger is filed with the Secretary of State of the State of Florida.
