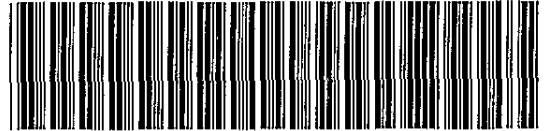

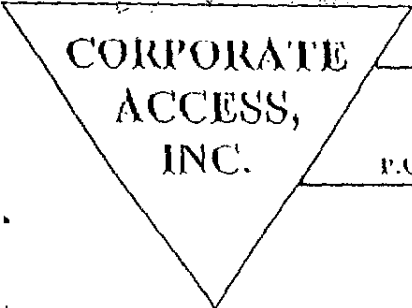

**ARTICLE IV: MANAGEMENT**

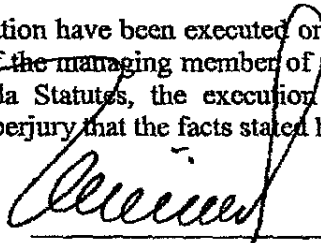

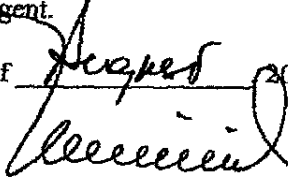

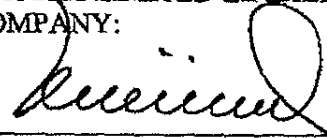
