FIRST: The date of filing of the Articles of Organization was September 1, 2004.

SECOND: The following amendments to the Articles of Organization were adopted by the Limited Liability Company:

1. The Articles of Organization of the Company are hereby amended by striking out ARTICLE I in its entirety and substituting the following new Article, as follows:

"ARTICLE I: NAME The name of the Limited Liability Company is: ACOSTA FINANCIAL SERVICES, LLC."

2. The Articles of Organization of the Company are hereby amended by striking ARTICLE II in its entirety and substituting the following new Articles, as follows:
