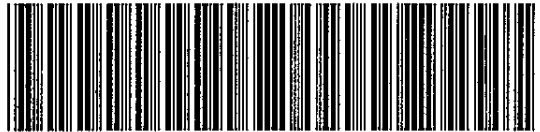

## ARTICLES OF ORGANIZATION

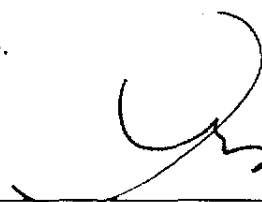

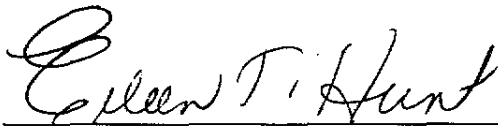
