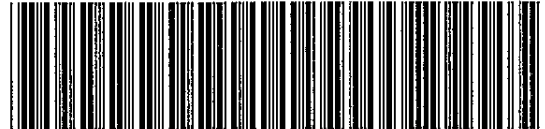

6. **Authority.** These articles are being signed by Jenny Aguaveva-Schmitt, one of the two initial members, who has full authority to sign and file them.

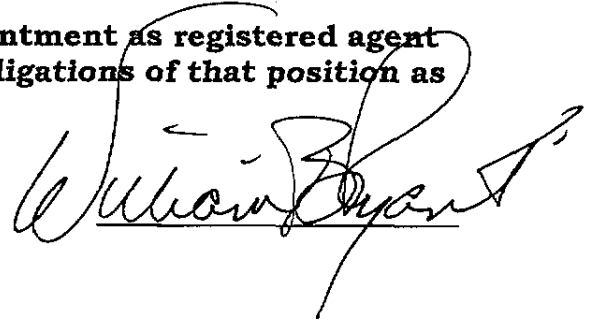
