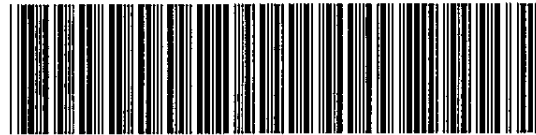



1. **Name.** The name of this Limited Liability Company shall be MOHAN ACQUISITON LLC. (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of Florida Statutes.
2. **Duration.** The Company shall exist from the date of filing these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. **Place of Principal Office.** The mailing address and the street of the Company's principal office is 400 No. Ashley St. Suite 2010, Tampa, Florida 33602.
5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Mark E. Pena. The street address of the initial registered agent of the Company is 334 S. Hyde Park Ave., Suite 444, Tampa, Florida 33606.
6. **Additional Members.** Additional members to the Company may be admitted, but only upon the consent of all of the other members of the company at the time admission is sought.
7. **Management of the Company.** The management of the Company shall be vested in the managers of the Company. The initial Manager shall be Sunrayz Products, Inc.
8. **Operating Agreement.** The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
