**ARTICLES OF ORGANIZATION  
OF  
GMIV RENTALS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

**ARTICLE I**

**Name**

The name of the limited liability company shall be GMIV RENTALS, LLC (the "Company"). The street and mailing address of the principal office of the Company in Florida shall be 1156 Cassat Avenue, Jacksonville, Florida 32205.

**ARTICLE II**

**Duration**

### Additional Capital Contributions

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

## ARTICLE VI

### Admission and Withdrawal of Members

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

## ARTICLE VII

### Termination of Existence

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

## ARTICLE VIII

### Manager

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall be elected in the manner set forth in the Operating Agreement of the Company. The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement.


