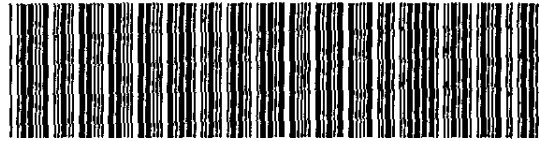

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
MARINE JET PROPULSION SYSTEMS, LLC**

Marine Jet Propulsion Systems, LLC, a Florida Limited Liability Company (the "Company"), whose Articles of Organization were filed on September 2, 2004, hereby certifies as follows:

1. The Articles of Organization of the Organization are hereby amended by deleting the present form of Article I, Section 1.2, in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE I
ORGANIZATION**

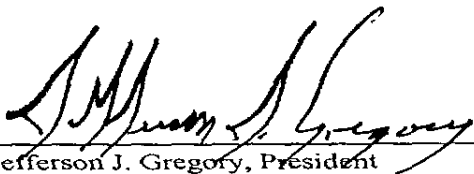
1.2 Name. The name of the company shall be Sword Marine Technology, LLC.
