## ARTICLES OF ORGANIZATION OF HOME TEAM ADVANTAGE, LLC

SECRETARISE SECRETARIAN

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida does set for the following:

#### **ARTICLE I - Name**
