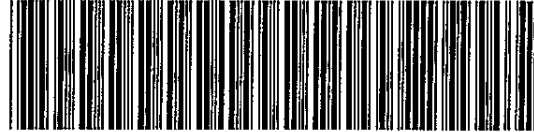



Additional members may be admitted with the unanimous consent of all Members.


ARTICLE VI – Members Right to Continue Business:


