## ARTICLES OF ORGANIZATION

OF

### FOTOGGRAPHIC.NET, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

#### ARTICLE I

##### NAME

The name of the limited liability company shall be FotoGraphic.Net, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 12041 Beach Boulevard, Suite 18, Jacksonville, Florida 32246.

#### ARTICLE II

##### DURATION

The Company's existence shall commence on the date these Articles of Organization are filed with the Florida Department of State and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

#### ARTICLE III

##### PURPOSES AND POWERS

### TERMINATION OF EXISTENCE




