
ARTICLE IV



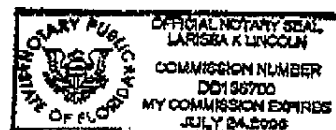
