**ARTICLES OF ORGANIZATION  
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I  
Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Marine Jet Holdings II, LLC (the "Company").

The Company's principal address and mailing address is 1815 North U.S. Highway 1, Ormand Beach, Florida 32174. The Company's initial registered agent is David M. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

**ARTICLE II  
Duration of Existence**


