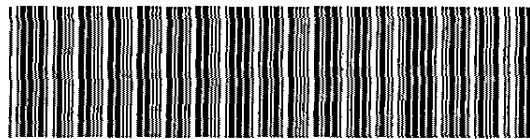

**ARTICLES OF ORGANIZATION
OF
TOWN PROPERTIES OF KISSIMMEE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 (the "Act"), hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Town Properties of Kissimmee, LLC ("company").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company shall be 1520 Crest Ridge Drive, Kissimmee, Florida 34746.

ARTICLE III – DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Patricia J. McCurdy, 1520 Crest Ridge Drive, Kissimmee, Florida 34746.

ARTICLE V—MEMBERS

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement. The members of the company are West Lake Toho Properties, LLC, a Florida limited liability company and PatMar of Kissimmee, LLC, a Florida limited liability company.

ARTICLE VI—INDEMNIFICATION

Except as expressly provided in the Operating Agreement, the company shall indemnify any member, or former member to the full extent permitted under the Act.
