Articles of Organization
Of

Defining Moments Event Productions, LLC

These Articles of Organization are made for the purposes of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608)

1. Name. The name of this limited liability company is Defining Moments Event Productions ("Company").
2. Duration. The company shall exist from the date of filing these Articles with the Department of State until the earlier of fifty years from the date of filing or the occurrences of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of any remaining members.
3. Mailing Address and Street Address. The Company's mailing address is P.O. Box 270998, Tampa, Florida, 33618-0998. The Company's street address is 19617 Deer Lake Rd., Lutz, Florida 33548.
4. Registered Agent and Office. The name of the initial registered agent of the Company is Ashley Ann Pergola. The street address of the initial registered agent of the Company 19617 Deer Lake Rd., Lutz, Florida, 33548.
5. Additional Members. Additional members to the Company may be admitted, but only if all of the current members agree to the admission of the additional members and to the terms of the admission.
6. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.
7. Management of the Company. The management of the limited liability company is reserved to the members. The following persons will initially be the managing members:
