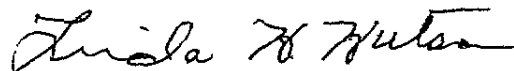

ARTICLE VIII. ADMISSION OF NEW MEMBERS

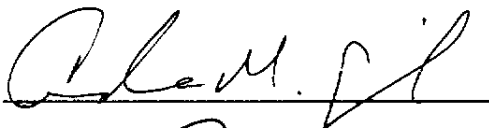
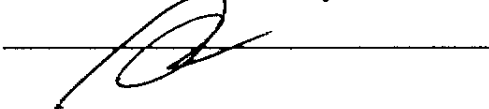

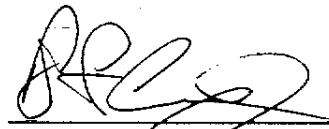
ARTICLE IX. MEMBERS RIGHT TO CONTINUE BUSINESS

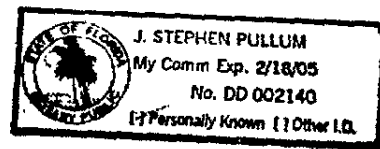
