ARTICLE I. NAME

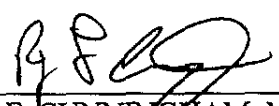
The name of the Limited Liability Company ("Company") is GATOR DONE GUIDE SERVICE, L.L.C.

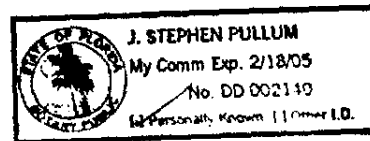
