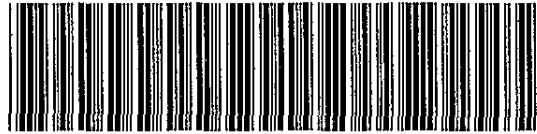

The street address and mailing address of the principal office of the limited liability company is 6460 NW 62nd Terrace, Parkland, FL 33067.

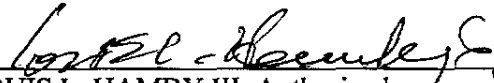
ARTICLE III - INITIAL REGISTERED AGENT
