ARTICLES OF ORGANIZATION

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (2000), as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

Article 1: Name

The name of this limited liability company is GIRVIN PLAZA, LLC (the "Company").

Article 2: Address

The mailing address and street address of the principal office of the Company is 12666 Mandarin Road, Jacksonville, FL 32223.

Article 3: Registered Agent and Registered Office

The registered agent and his office are Howard J. Smith, Esq., 12443 San Jose Boulevard, Suite 1004, Jacksonville, FL 32223.

Article 4: Management

The Company will be a manager-managed company in accordance with, and subject to, the requirements of the Act and the Operating Agreement of the Company.

Article 5: Purpose

The Company's business and purpose shall consist solely of the following:

- a) to engage solely in the ownership, operation and management of the real estate project known as Girvin Plaza located on Atlantic Boulevard in Jacksonville, Florida (the "Property"), pursuant to and in accordance with these Articles of Organization and the Company's Operating Agreement; and
- b) to engage in such other lawful activities permitted to limited liability companies by the applicable laws and statutes for such entities of the State of Florida as are incidental, necessary or appropriate to the foregoing.
