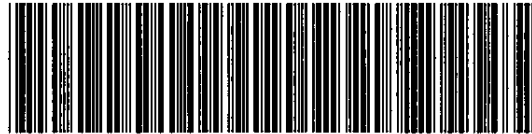

3. The date on which the dissolution was approved was **March 31, 2006.**


