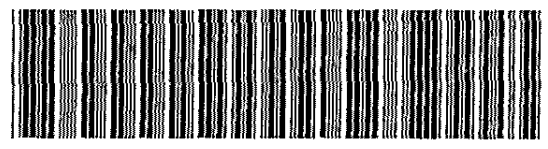



ARTICLES OF ORGANIZATION
OF
RED YABA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, subscribe, acknowledge and file these Articles of Organization.

ARTICLE I

The name of the company shall be: RED YABA, L.L.C.

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved as provided in these articles of organization or in regulations.

ARTICLE IV

The Limited Liability Company is being organized for the purpose of the purchase, sale, development, lease or other dealings in real or personal property and in such other activities as may be permitted or authorized by law.

ARTICLE V

The name and street address of the initial registered agent of the company in the State of Florida is Kevin Yarina, 5 Fountainebleau Circle, Daytona Beach, Florida 32118.

ARTICLE VI

Each member shall make additional capital contributions to the company on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE VII


ARTICLE IX

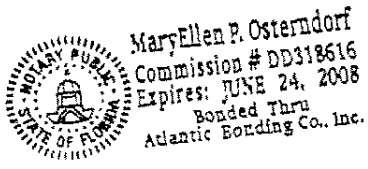
