



ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF MAINSTREAM PHYSICAL THERAPY, LLC



The undersigned certify that we have as of the date indicated below, amended the Articles of Organization as provided herein, and in connection therewith set forth the following information in accordance with Section §608.411, Florida Statutes:

- 1. The name of the limited liability company is MAINSTREAM PHYSICAL THERAPY, LLC.
 - 2. The date of filing of the Articles of Organization is September 10, 2004.
 - 3. The amendment to the Articles of Organization is as follows:

Article III is amended to read as follows:

ARTICLE III

EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed by one manager, who shall be selected by a majority vote of the members of the limited liability company.

PROFITS AND LOSSES

ARTICLE VII.

- (a) Profit Sharing.
