**ARTICLES OF ORGANIZATION OF  
MISS YA 3 TRUCKING COMPANY, LLC**

(Pursuant to Section 608.407, Florida Statutes)

**ARTICLE I - NAME**

The name of the limited liability company is MISS YA 3 TRUCKING COMPANY, LLC.

**ARTICLE II - ADDRESS**

The mailing and street address of the company is 5700 Bingham Road, Milton, Florida 32583.

**ARTICLE III - PURPOSE**

The company has been organized for commercial development and any other lawful business.
