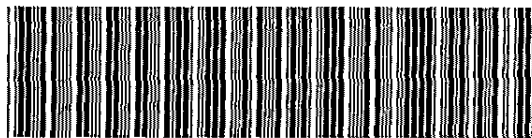



ARTICLE I




