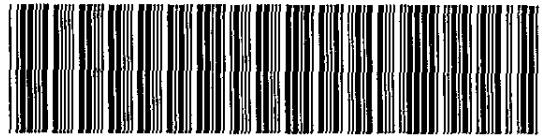

## ARTICLES OF ORGANIZATION OF THE OLD TIN SHED, LLC

### Article I

The name of the limited liability company ("Company") is THE OLD TIN SHED, LLC.

### Article II

dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Operating Agreement.


#### Article VIII
