ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF RELIANCE PETROLEUM HOLDINGS LLC

- 2. The Original Articles were amended pursuant to two Articles of Amendment (the "Prior Amendments") filed on September 6, 2005 and December 6, 2011, respectively; the second Amendment changed the name of Company from Diamond Oil, L.L.C., to its current name of Reliance Petroleum Holdings LLC. (The Original Articles, as amended by the Prior Amendments, are hereinafter referred to as the "Amended Articles.")
- 3. The Amended Articles are hereby amended as follows:
 - a. Article X of the Original Articles, is hereby amended to read as follows: The Company is to be managed by one or more managers and is therefore a manager managed limited liability company.
 - b. Article IX of the Original Articles is amended to add the following sentence to the end of the existing paragraph: These Articles of Amendment may be amended by the affirmative vote or written consent of a majority of the membership interests in Company (referred to as "Units" in Company's Operating Agreement).
- 4. The Amendment set forth herein was approved by the holders of all of the membership interests of the Company. The number of votes cast for the Amendment was sufficient for approval.
