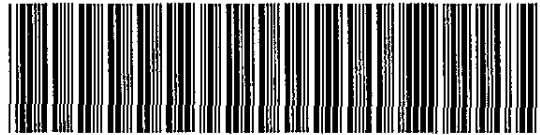

ARTICLE I - Name: The name of the Limited Liability Company is: Deitzer, LLC.


