**ARTICLES OF ORGANIZATION
OF
CRISTIAN J. PRESUTTI, M.D., P.L.**

The undersigned, hereby associate themselves for the purpose of becoming a professional limited liability company under the provisions of Chapter 808, FLORIDA STATUTES (2003), the "Florida Limited Liability Company Act", and Chapter 621, FLORIDA STATUTES (2003), the "Professional Service Corporation and Limited Liability Company Act" of the State of Florida, and pursuant to the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company ("Company") is *Cristian J. Presutti, M.D., P.L.*

ARTICLE II

Address. The mailing and street address of the Company's principal office is 2964 N.E. Rosefree Drive, Jensen Beach, FL 34957.

ARTICLE III

Duration. The period of duration for the Company is perpetual beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Purpose: The purpose of the Company shall be and is to engage in every aspect of the practice of medicine as defined and regulated by Chapter 458, FLORIDA STATUTES (2003).

The professional services involved in the corporation's practice of medicine may be rendered only through or supervised by its officers, agents and employees who are duly authorized and licensed as a medical doctor in the State of Florida.

ARTICLE V

Management. The Company is to be managed by its members.

ARTICLE VI

Membership in Company. Membership in the Company may be owned only in the name or names of an individual or individuals who are duly authorized and licensed to practice medicine in the State of Florida, and no member of this Company may sell or transfer any membership interest in this Company except to another individual who is then duly authorized and licensed to practice in the State of Florida.

The members of the Company are specifically authorized from time to time to adopt an Operating Agreement not inconsistent herewith restraining the alienation of membership interests in the Company and providing for the purchase or redemption by the Company or its members of membership interests in the Company.

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

Upon the death of a member, his membership interest shall be subject to purchase by the Company or by the other members at such price and upon such terms and conditions and in such manner as may be provided for in the Operating Agreement of this Company, or by written agreement between the Company and its members or by written agreement among the members, in a manner consistent with law and these Articles.

ARTICLE VII

Continuation of Business. The remaining members of the Company have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business of the Company may be continued only on the written consent of a majority of the remaining members.

ARTICLE VIII

Amendment of Articles. These Articles of Organization shall be amended as follows: every proposed amendment to these Articles of Organization shall require the approval at a Member's meeting of a majority of the members entitled to vote thereon; alternatively, a majority of the Members may sign a written statement adopting the proposed Amendment to these Articles of Organization.

ARTICLE IX

Operating Agreement. The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the Members of the Company at a meeting of the Members; alternatively, all of the Members may sign a written statement adopting the proposed Operating Agreement or changes thereto.

ARTICLE X

Registered Agent and Office. The name of Company's initial registered agent in Florida is Cristian J. Presutti. The address of Company's registered office in Florida is 1701 S.E. Hillmoor Drive, Suite 7, Port St. Lucie, FL 34852.

ARTICLE XI

Preemptive Rights. The Members of the Company shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Members, such membership interests as may be issued for money, or any property or services from time to time, in addition to the present memberships. The preemptive right of any Member is determined by the ratio of the membership interest held by a Member to all membership interests currently outstanding.

ARTICLE XII


