

ARTICLES OF AMENDMENT

OF

GULF BRISAS, LLC

The name of the limited liability company is Gulf Brisas LLC.

The Articles of Organization of Gulf Brisas, LLC were filed with the Florida Department of State on September 20, 2004, and subsequently amended on September 29, 2004.
