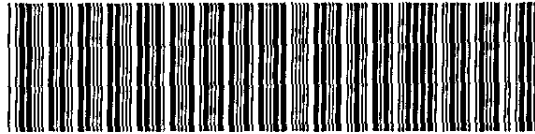




The new article VI of Paradiso Park LLC articles of organization is as follows:

**THRID:** The date of this amendment's adoption: September 16, 2005


