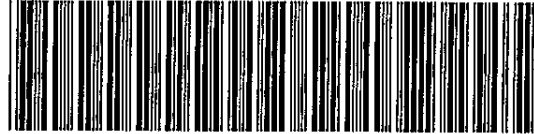



The Marké Cafe, LLC**


The undersigned persons acting as Organizers of a limited liability company under the Florida Limited Liability Company Act adopt the following Articles of Organization:


