**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
EAST COAST DEVELOPMENT, LLC**

Pursuant to Section 608.411, Florida Statutes, EAST COAST DEVELOPMENT, LLC, a Florida limited liability company, hereby amends and restates, in its entirety, its Articles of Organization originally filed with the Florida Department of State on September 24, 2004, as follows:

**ARTICLE I
NAME**

The name of this limited liability company shall be "East Coast Development, LLC" (the "Company").

**ARTICLE II


