
2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 574 Marmora Avenue, Tampa, Florida 33606.

5. **OPERATING AGREEMENT.** The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company.


