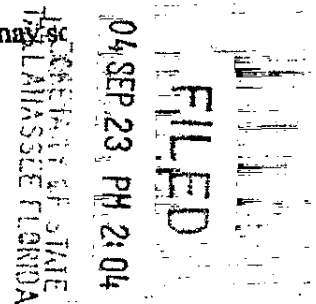
**ARTICLE I****Company Name and Principal Office**
