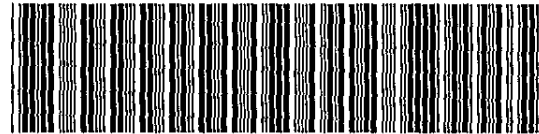

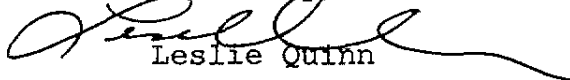

**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be Eagle Transport, L.L.C.

**ARTICLE II -- ADDRESS**

The mailing and street address of the principal office is 14360 SE 96<sup>th</sup> Ct., Summerfield, FL 34491.

**ARTICLE III - PURPOSE**

The limited liability company is purposefully organized to operate for any and all lawful purposes.

**ARTICLE IV-DURATION**

The limited liability company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in Operating Agreement.

#### ARTICLE V -- REGISTERED OFFICE AND AGENT

The name of the registered agent and the street address of the registered agent of the limited liability company in the State of Florida is: Margaret Besley of 14360 SE 96<sup>th</sup> Ct., Summerfield, FL 34491.

#### ARTICLE VI -- INITIAL AND ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make initial capital contributions in cash, services and/or property, however, each member shall continue to make additional capital contributions to the limited liability company only with the consent of the members having a majority of the capital interests in the company who are entitled to vote, or as otherwise provided in the Operating Agreement.

#### ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the written consent of the members having a majority of the capital interests of the company entitled to vote and on the terms and conditions as shall be determined by those members. A member may also transfer his or her interest in the company only with the written consent of the members having a majority of the capital interests of the company entitled to vote and on the terms and conditions as shall be determined by those members, unless otherwise stated in the Operating Agreement. Except as otherwise set forth in the Operating Agreement and/or Bylaws of the company, the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless members having a majority of the capital interests of the company entitled to vote approve of such participation and allow the transferee to become a member. Such approval must be provided in writing.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall not be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless otherwise stated in the Operating Agreement or Bylaws, and only by a majority vote of the remaining members.

ARTICLE VIV -- MANAGEMENT

The limited liability company shall be initially managed by Curtis Besley and shall continue to be managed by this member unless otherwise mandated in accordance with the Operating Agreement and/or Bylaws adopted by the members for the management of the business and affairs of the company. The Operating Agreement and Bylaws may contain any provisions for the regulation and management of the affairs of the limited liability company not inconsistent with law or these Articles of Organization. The address of the initial member manager is 14360 SE 96<sup>th</sup> Ct., Summerfield, FL 34491.

ARTICLE X-AMENDMENT, MODIFICATION, OR REPEAL OF THE ARTICLES OF ORGANIZATION, THE OPERATING AGREEMENT, OR BYLAWS

Except as set forth in the Operating Agreement and Bylaws, no amendment, modification or repeal of the Articles of Organization, Operating Agreement or Bylaws may be made without the written consent of the members having a majority of the capital interests of the company entitled to vote and on the terms and conditions as shall be determined by the those members.

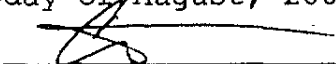

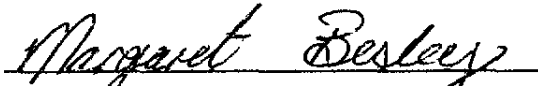
