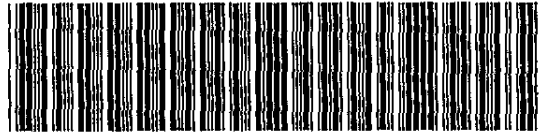




FIRST: The Articles of Organization were filed on September 27, 2004 and assigned document number L0400070278.
