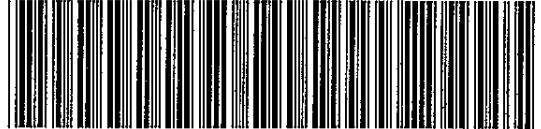

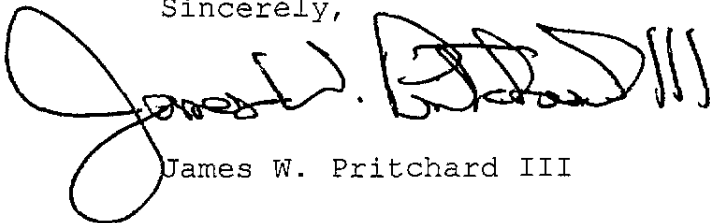

**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be Bomar Motorsports, L.L.C. (the "company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 9625 Denton Avenue, Hudson, Florida 34667.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

**ARTICLE IV -- PURPOSE**

The purpose for which the company is organized is to engage in any and all business or activities permitted under the Laws of the United States and the State of Florida. The company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

## ARTICLE VI - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company in the manner prescribed by the Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

## ARTICLE VII - ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

## ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

## ARTICLE IX - MANAGEMENT


The company shall be managed by a manager in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization. 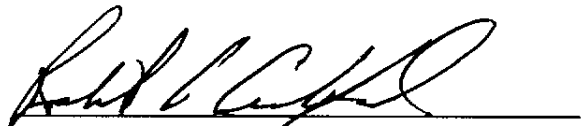
