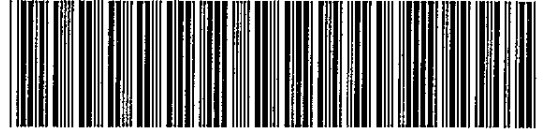

ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The name of this limited liability company is: Calla Lily Development, LLC

ARTICLE II - PRINCIPAL PLACE OF BUSINESS
