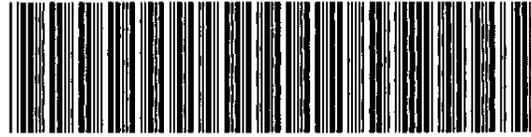

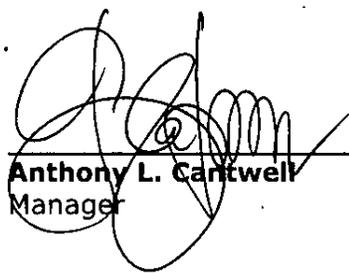
FIRST: The date of filing of the Articles of Organization was **September 28, 2004** and the document number assigned was L04000070521.
