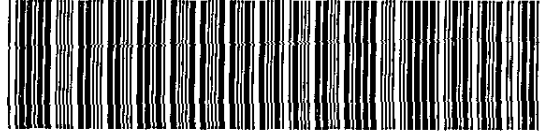

Charles Dodson shall be removed as a member.


