

ARTICLES OF ORGANIZATION OF PLANT SOURCE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be PLANT SOURCE, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be P.O. Box 565, New Smyrna Beach, Florida 32170 and 4553 S. Atlantic Avenue, Unit A2, New Smyrna Beach, Florida 32169 respectively.
