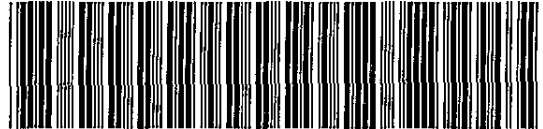

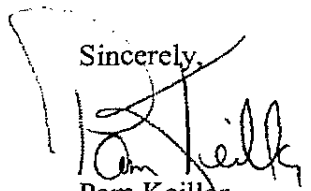

**ARTICLES OF ORGANIZATION
OF
ACTION DESIGN AND CONSTRUCTION, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article I- Name

The name of the limited liability company is Action Design and Construction, LLC (the "Company").

Article II- Duration

The duration of the Company shall be perpetual, unless it is sooner dissolved in accordance with applicable law or its Operating Agreement.

Article III- Mailing Address and Street Address

The Company's initial mailing address is P.O. Box 15064, Tallahassee, Florida 32317. The Company's initial street address is 2810 Remington Green Circle, Tallahassee, Florida 32308.

Article IV- Registered Agent and Office

Article V- Additional Members

Additional members to the Company may be admitted, but only pursuant to the Company's Operating Agreement.

Article VI- Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Operating Agreement.

The Company shall be managed by its members in accordance with procedures set forth in its Operating Agreement.

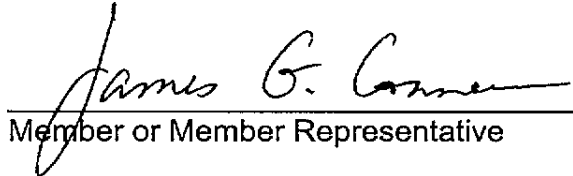
Article VIII- Operating Agreement

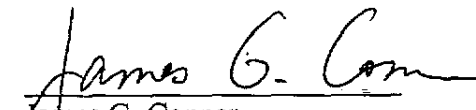
