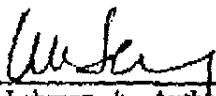
ARTICLES OF ORGANIZATION

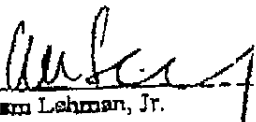
