**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Ch. 608, Florida Statutes).

**ARTICLE I**

**NAME**

#### **ARTICLE X**


#### **POWERS**
