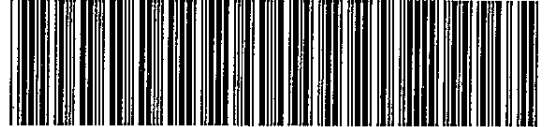

ARTICLE V — Limitation on Agency Authority of Members:


Pursuant to section 608.4235 of the Florida Limited Company Act, NO member of the Company shall be an agent of the Company solely by virtue of being a member.
