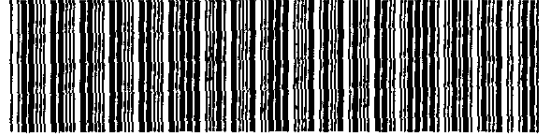

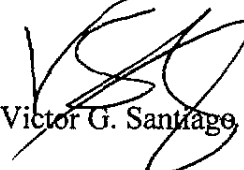

All debts, obligations and liabilities of the limited liability company have been paid or discharged.

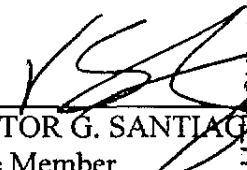
**ARTICLE V**
