ARTICLES OF ORGANIZATION

ARTICLE NINE

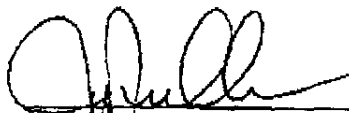
The Company is to be member managed.
